- C. The Rich's are concern regarding the drainage in between 5 and 7 Judith. With it being so costly we've started to fix our yard ourselves, however myself and the gentleman from Howard noticed the drainage pipe leads into a swamp area in between the Katz and their neighbors and if that area does not get cleaned out the water is just going to continue to back up into my yard. I have Rory researching this IAW the by Laws. We should not have to pay the 75% they requested. Our lawyer has provided us a response.
- D. Gaspar Obimba is looking to do the following outdoor projects: 1: He is looking at installing solar on the roof (back side and garage side roof) and Sunrun or Tesla would be leading this process. If we approve the above, they need to drop some large trees. 2: He is also trying to install an exterior door to the garage upstairs so he can move a couch up there, the current door won't allow him to even move a small seat up there. For that to happen, He would also need to install staircases on the west side of the house. Still no action taken.
