Board of Directors Meeting Minutes - Nov 28, 2011

The meeting was called to order at 7:33PM. Officers/Directors in attendance were President Jerry Iacuzio, Vice President Rose Crepeau, Treasurer Jeff Katz, Secretary Mariano Santangelo and directors Bob Mullaney and Shawn Goldthwaite.

Meeting Minutes – The November 6 minutes were read and approved.

Treasurer's Report (J. Katz) – A thorough Treasurer's report was provided, with the following specifics:

## A. Current Financials

- 1. Jeff reported that the bank account was up to \$19,971.11 and \$0 in undeposited condo fees.
- 2. **9** homeowners are now more than three months behind.
- 3. **6** homeowners are now more than six months behind.

The Treasurer's report was approved as submitted.

#### **Old Business**

- **a.** Have opened the account for automatic deposit and credit card payment for condo fees with Citizen's Bank. A form has been created to send to those interested on signing up. Fees will be \$5 per month for credit card and \$1 per month for direct deposit.
