**Board of Directors Meeting Minutes – Nov 7, 2010** 

The meeting was called to order at J. Katz house at 7:30 pm. Officers/Directors in attendance were President Jerry Iacuzio, Treasurer Jeff Katz, Secretary Mariano Santangelo and directors Bob Mullaney and Randy Hoidalh.

**Meeting Minutes** – The September minutes were read and approved.

Treasurer's Report (J. Katz) – A thorough Treasurer's report was provided, with the following specifics:

#### A. Current Financials

- 1. Jeff reported that the bank account was up to \$15,071.06 and \$125 in undeposited condo fees.
- 2. **10** homeowners are now more than three months behind.
- 3. **6** homeowners are now more than six months behind.

#### B. Leans

- 1. The current liens are: 32 Wright Rd, 1 Donovan Dr, 14 Donovan Dr, 17 Wright Rd, 26 Wright Rd and 10 Judith Ln.
- 2. Vacated leans 32 Wright Rd. (Bank of America paid back fees and are now ahead).
- 3. New lien is needed for owner at 15 Donovan Dr and 29 Wright Rd.
- **D. Small Claims court status** 32 Wright Rd. is the only one still in progress.
- **E. Foreclosure Sales:** 17 Donovan Dr foreclosed on July 14.
- **F. Top 5 offenders**: owe an approximate amount of \$11,600.
- G. Reminder Letters: sent to homeowner of 29 Wright Rd., 15 Donovan Dr. and 17 Wright Rd.

The Treasurer's report was approved as submitted.

### **Old Business**

- **a.** Database: Database is still not complete.
- **b.** Filing System: no updates.
- **c.** Investigate "super lien" in process with our lawyer.
- **d.** Dogs letters were sent out by Randy. We haven't received any kind of feedback.
- e. Election is December need to fill 3 slots. The members up for election are: Jeff Katz, Kevin Yorke, Randy Hoidahl and Bill Hankey. New candidate: Rose Crepeau of 1 Rachel Court. The ballot will go out with the statement due back on December 31. A brief candidate resume will be posted in the website.
