Board of Directors Meeting Minutes - Sep 29, 2013

Treasurer's Report (J. Katz) - A thorough Treasurer's report was provided, with the following specifics:

A. Current Financials

- 1. Jeff reported that the bank account was up to \$25,834 and \$345.00 in undeposited condo fees.
